

Mr. Dria and Mr. Miller discussed the violations They testified that the business failed to maintain compliance with the Ohio Uniform Food Code, Ohio Administrative Code (OAC) 3717 at a retail food establishment and that the violations included no potable water, the presence of animals, poor sanitation and an accumulation of junk and clutter.
