

Influenza and Influenza-like Illness Surveillance

Media Talking Points

Activity Level: **Regional Activity**

- Definition: Increased ILI in ≥ 2 but less than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions, OR institutional outbreaks (ILI or lab confirmed) in ≥ 2 but less than half of the regions AND recent (within the past 3 weeks) lab confirmed influenza in the affected regions.

Surveillance Data:

- Influenza-like Illness (ILI) Sentinel Providers reported 0.30% of patients had ILI signs and symptoms. Influenza-like Illness is defined as a fever ($\geq 100^\circ$ F), **and** cough and/or sore throat. Temperature can be measured in the physician's office or at home.
- Over-the-counter (OTC) sales experienced a statistically significant deviation from the expected in three regions.
- Emergency department visits experienced a statistically significant deviation from the expected in four regions.
- ODH lab reported 126 positive confirmed isolates (total through 3/24/09). Circulating Strains: (82) Influenza A/ (H1N1), (44) Influenza B/Malaysia-like.
- Influenza B viruses currently circulating in the U.S. can be divided into two lineages represented by the B/Yamagata/16/88 and B/Victoria/02/87 viruses. The influenza B viruses identified by the ODH lab belong to the B/Victoria lineage and are not related to the current vaccine strain.
- Influenza-associated hospitalizations reported indicate 73 positive results by culture confirmation (total through 3/24/09): (51) Influenza A, (22) Influenza B.
- Incidence of 2009 confirmed influenza-associated hospitalizations = 420 (total through 3/24/09).
- Two confirmed influenza-associated pediatric mortalities have been reported: one from Hamilton County with influenza A, and one from Brown County with influenza B (through 3/25/09).

Analysis Considerations:

- No significant or confirmed geographic clustering of any data was detected.
- Influenza-associated hospitalization became a reportable condition on 1/1/09. Therefore, only cases that were entered after 1/1/09 will be considered for analysis purposes.
- The Ohio Department of Health Laboratory (ODHL) conducts culture confirmation for influenza testing, and these results are used in conjunction with other data sources to determine Ohio's influenza activity level each week. Viral culture tests that are reported for cases of influenza-associated hospitalizations will also be taken into consideration when determining influenza activity levels.
