
Stark County's Influenza Weekly Report Week 16 (4/15/18-4/21/18)



During Week 16:

- During Week 16, Stark County had 11 influenza-associated hospitalizations.
- Nationally, there were 4 influenza-associated pediatric deaths reported.
- There were no human infections with a novel influenza A virus reported during Week 16.
- During Week 16, 64 influenza A specimens were collected nationally from public health laboratories, which made up 29.6% of all positive specimens; 31.3% subtyped as the 2009 H1N1 virus, 67.2% subtyped as the H3 virus, and the remainder not subtyped.




So Far this Year:


- There have been 695 influenza-associated hospitalizations so far this year in Stark County.
 - Ages of those hospitalized for influenza have ranged from 1 month to 100 years of age with the median age being 71 years old.
- A cumulative rate of 105.3 lab-confirmed influenza-associated hospitalizations per 100,000 people was reported.
- Up through Week 16, 51,376 specimens were collected nationally from public health laboratories. 37,116 were typed as influenza A, comprising 72.2% of all specimens collected. Of these 14.4% were subtyped as the 2009 H1N1 virus while 83.9% were subtyped as the H3 virus.
- Nationally, there have been 160 influenza-associated pediatric deaths reported so far this year. Last year at the same time, there were 100.

Viruses Circulating vs. Viruses in this Year's Vaccine:

- Nationally since October 1, 2017, 1,843 influenza A specimens were genetically or antigenically characterized.
 - ➤ There were 1,157 influenza A (H3N2) viruses collected, a sample showing significant genetic diversity. 97% of those antigenically characterized matched the influenza A (H3N2) component in this year's vaccine. There were 686 influenza A (H1N1) viruses collected; all of those characterized matched the influenza A (H1N1) component in this year's vaccine.
- Nationally since October 1, 2017, 934 influenza B specimens were genetically or antigenically characterized.
 - ➤ Of these, 613 were antigenically characterized from the Yamagata Lineage and 180 characterized from the Victorian Lineage. Of these specimens, 100% of the Yamagata Lineage matched the Influenza B component of the 2017-2018 vaccine and 24% of specimens from the Victorian Lineage matched.

Graph 1: Hospitalized and Non-Hospitalized Influenza Cases Reported to the Local Health Department.






- ♦ There were 15 cases of hospitalized and non-hospitalized influenza reported for Week 16 in Stark County. Last year at this time there were 5 cases. Stark County's cumulative case load is 1,747 cases, compared with 945 total cases through Week 16 of last year.

Graph 2: Sentinel Provider Reported Influenza Like Illness (ILI) in Stark County.


◆ During Week 16, Stark County Sentinel Providers reported 0.6% of visits for ILI. Nationally, it was reported that 1.7% of visits were for ILI, which is below the national baseline at 2.2% of visits.


◆ ED and Stat Care visits for respiratory and constitutional syndrome decreased but continue to remain above the multiyear baseline average during Week 16.

 ED and Stat Care visits for ILI + Fever for MMWR Week 16 continued to drop but remained above the multiyear average.




 School absenteeism finished reporting for the 2017-2018 influenza season.
