The hearing for Club Faded located at 201 Dueber Ave SW, Canton, Ohio was called to order by Dr. Stephen Hickman at 11:32 AM.


A representative of the business was not present. Gus Dria was sworn in to testify.


## Hearing


The owner was not present. Gus Dria was sworn in to testify.




