
Hearing


Property owner, Clinton Miner Jr., was not present. Gus Dria was sworn in to testify.





The hearing for the property at 12th St SE, Canton, Ohio was called to order by Dr. Steven Hickman at 11:41 AM.


The property owner, Dennis Toth, was not present. Gus Dria was sworn in to testify.






