MEETING MINUTES

Call to Order and Roll Call

Dr. Hickman called to order the regular meeting of the Board of Health of the Canton City Health Department on Monday, October 27, 2014 at 12:02 pm with a quorum present.

Dr. Hickman, Dr. Fiorentino, Dr. Lakritz and Ms. Snell were present. Also present was Jim Adams, Leigh Page, Dr. Mader and Christi Allen. Mayor Healy was in attendance during the discussion of the General Fund Budget for Fiscal Year 2015.

Approval of Minutes of Meeting Held September 22, 2014

Dr. Fiorentino moved and Ms. Snell seconded a motion to approve the minutes of the regular meeting held September 22, 2014. Motion passed unanimously.

<u>Consideration of Approval for the Purchase of Sleep Sacks at a Cost not to Exceed \$11,000.00 for the Infant Mortality Study</u>

This agenda item was moved from agenda item number 14 to before the bills are approved.

Dr. Lakritz moved and Ms. Snell seconded a motion to approve the purchase of sleep sacks at a cost not to exceed \$11,000.00 for the Infant Mortality Study. Motion passed unanimously.

Consideration of Approval of General Fund Budget for Fiscal Year 2015

Mayor Health spoke in regards to the Health Department's General Fund Budget for Fiscal year 2015. Mayor Health stated that the Health Department will need to cut their overall budget by 10%.
