
Stark County's Influenza Weekly Report Week 49 (12/5/2021 – 12/11/2021)

During Week 49:

- Stark County had one influenza-associated hospitalization.
- Nationally, zero influenza-associated pediatric deaths were reported.



Distribution of Influenza-Associated Hospitalizations by Age Group with Age-Adjusted Rate in Stark County



There were three cases of hospitalized and non-hospitalized influenza reported for Week 49 in Stark County. Last year, there were zero cases reported during this week. Stark County has reported 17 cases so far this year compared to the zero cases reported by this time last year.








Graph 3: Emergency Department Visits for Respiratory and Constitutional Syndromes.


 ED and Stat Care visits for respiratory and constitutional syndrome were reported at 34.93% of ED visits, which exceeded the multi-year baseline average during week 49.

 ED and Stat Care visits for ILI + Fever were reported at 3.64% of ED visits, and remained below the multi-year baseline average during week 49.



 During week 49, Stark County schools reported a total median absenteeism of 9.04%. Absenteeism due to influenza-like-illness was reported at 0.42% of all absences. 39 schools reported.




<u>Map:</u> ILI Activity Level Indicator Determined by Data Reported to ILINet.

(Data collected in ILINet may disproportionally represent certain populations within a jurisdiction or CBSA, and therefore, may not accurately depict the full picture of influenza activity for the entire jurisdiction or CBSA. Differences in the data presented here by CDC and independently by some health departments likely represent differing levels of data completeness with data presented by the health department likely being the more complete.)

A Weekly Influenza Surveillance Report Prepared by the Influenza Division Influenza-Like Illness (ILI) Activity Level Indicator Determined by Data Reported to ILINet

This system monitors visits for ILI (fever and cough or sore throat), not laboratory confirmed influenza and may capture patient visits due to other respiratory pathogens that cause similar symptoms. 2021-2022 Influenza Season Week 49 ending December 11, 2021



For 2021-2022, the influenza report will include the visual representation of ILI activity as a replacement for the visual of geographic spread of influenza as assessed by State and Territorial Epidemiologists. This is due to the CDC suspending the system used for this reporting. Data collected in ILINet are used to produce a measure of ILI activity by state/jurisdiction and Core Based Statistical Areas (CBSA).

Geographic Spread of Influenza as Assessed by State and Territorial Epidemiologists

Due to the impact of COVID-19 on ILI surveillance, and the fact that the state and territorial epidemiologists report relies heavily on ILI activity, reporting for this system will be suspended for the 2021-2022 influenza season. Data from previous seasons is available on FluView Interactive.
