


# Stark County's Weekly Influenza Report

Week 20 (5/17/15-5/23/2015)

The Percentage of Influenza Types for the 2014-1015 Season in Stark County



➤ The predominate strain identified locally has been influenza A (75%). Nationally, influenza A stands at 84% of the specimens tested.


## Last Week of the Reporting Season

- During MMWR week 20, there were 4 influenza-associated hospitalizations in Stark County. The total for the season thus far is 578.
- In Stark County, 69% of the season's influenza-associated hospitalizations were age 65 or older.
- Nationally the cumulative rate for the season thus far is 65.5 laboratory-confirmed influenza-associated hospitalizations per 100,000 population.
- Of the 104,822 influenza A specimens collected nationally, 0.2% subtyped as the 2009 H1N1 virus, 49.9% subtyped as the H3 virus, and the rest were not subtyped.
- Nationally, 1,324 of the influenza A (H3N2) viruses collected were antigenetically characterized since October 1, 2014. Of those characterized, 81.4% were drifted (significantly different) that this year's influenza vaccine.

- Of the 810 specimens characterized nationally as Influenza B, 582 subtyped from the Yamagata Lineage and 228 subtyped from the Victorian Lineage.
- During week 20, National Pneumonia and Influenza (I&P) Mortality Surveillance of all deaths reported through the 122 Cities Mortality Reporting System as due to P&I was at 6.4%. This is below the 6.6% epidemic threshold for this week.
- Nationally, a total of 141 influenza-associated pediatric deaths have been reported. Out of those deaths, two were reported during week 20. Stark County remains having no pediatric deaths associated with influenza.

**Graph 1: Influenza Cases Reported to the Local Health Department.**


- ◆ During week 20 there was a total of 4 reports of hospitalized and non-hospitalized influenza. This week last year had 1 case.
- ◆ This year's reports total at 1,078. The total number of reports for last year by this week was 653.

**Graph 2: Sentinel Provider Reported Influenza Like Illness (ILI) in Stark County.**




◆ During week 20, ED and Stat Care visits for respiratory and constitutional syndrome remained just above the multi-year baseline.

◆ During week 20, ED and Stat Care visits for influenza like illness (+fever) continued below the multi-year baseline.




